# WELCOME to the 2025 rebranded, redesigned, reimagined TOWN SQUARE MARKET, formerly known as the Cranberry Township Farmer's Market.

We are so excited to bring this amazing community event to the families and friends in the Pittsburgh North Region. There is a lot of new information, so please read through this document carefully to apply as a Food Truck Vendor.

We are accepting Food Truck Vendors who sell food available for consumption at the market, (hot or cold), desserts/ice-creams/smoothies, etc. or non-alcoholic beverages from a self-contained, motorized vehicle or a self-contained enclosed trailer with valid license plates and registration.

Promotional and Service type vendors will be accepted at our three (3) Special Events only. Please contact the Chamber at 724-934-9700 x 10 for more information regarding attending the Special Events.

#### ALL FOOD TRUCK VENDORS will need to submit this Vendor Application to be considered for the TOWN SQUARE MARKET.

Submission of this application does not guarantee acceptance into the Market. You will be notified by phone or email if your application is approved. Once approved, you will need to complete a Vendor Agreement, provide your Certificate of Insurance, and submit payment.

Food Truck space is limited and will be monitored to avoid an overlap in food offerings.

#### SPECIAL DETAILS of the newly designed TOWN SQUARE MARKET:

- Our NEW location will be along the walkways of the Armstrong Great Lawn, located in the front and side of the Cranberry
  Municipal Building at 2525 Rochester Road, Cranberry Twp. and also in the upper and lower side parking lots of the
  building. Food Truck Vendors will be located in the lower side parking lot.
- There will be VERY SPECIFIC drop off and set up details this year to avoid a backup of vendors. We will provide you with your parking location and set-up time/instructions as we get closer to the Grand Opening on June 6<sup>th</sup>.
- Market months are June, July, and August only. (June 6<sup>th</sup> through August 29<sup>th</sup>)
- There is NO Market on July 4<sup>th</sup> or August 8<sup>th</sup>.
- The Market will open at 4:00pm and close at 7:00pm. Food Truck Vendors will be asked to let us know how long you
  will need to park in your spot and set up beforehand. The Market opens promptly at 4pm so we kindly ask our Food
  Trucks to be ready to serve customers by 4pm.

• Three (3) Special Event Days are: June 6<sup>th</sup> Grand Opening Celebration, July 25<sup>th</sup> Christmas in July, August 15<sup>th</sup> Kids Back to School Bash.

- 1.) You will be contacted by the PNRC within 2-3 weeks after your application has been reviewed.
- 2.) Upon approval, a Vendor Agreement will be emailed to you that will need to be completed and returned.
- 3.) A Certificate of Insurance must be provided listing Pittsburgh North Regional Chamber as an Additional Insured for up to \$1,000,000. You can mail or email the Certificate to the Chamber prior to the Grand Opening.

- 4.) Payment will be due via credit card or check made payable to: Pittsburgh North Regional Chamber
- 5.) Prior to the Grand Opening on June 6<sup>th</sup>, you will be contacted regarding your space location and drop off/set up details.

Failure to complete all the above steps will result in cancelling your attendance at the Town Square Market.
